Federal Title IV Funds Policy

Policy:

Title IV is a term that refers to federal financial aid funds. Federal regulations state that any federal funds disbursed to a student's account in excess of allowable charges must be delivered to the student (or parent in case of an undergraduate PLUS loan).

If other non-allowable charges (such as health center charges, parking permit, book voucher charges, etc.) are on the account, an outstanding balance due may exist after the Title IV excess has been delivered.

To prevent an outstanding balance due, students or parents may authorize Clarion University to apply excess funds to the student account for non-allowable charges by signing an authorization form.

Title IV Calculation Example

The above table shows that Ernie Eagle has a credit balance of \$1,934.80 on his student account. Ernie's \$1,934.80 credit balance is the difference between the total of all his charges (\$9,135.20) and the total of all his payments (\$11,070.00).

However, the table below shows that Ernie has a Federal Title IV excess of \$2,194.80. The Title IV calculation is based upon the difference between the total allowable charges (\$8,875.20) and his total Title IV funds (\$11,070.00).

Federal Title IV Funds - Allowable Charges = Excess Title IV Funds

11,070.00 - 8,875.20 = 2,194.80

If Ernie elects to receive the Title IV excess of \$2,194.80, a balance due of \$260 (\$2,194.80-\$1,934.80) would exist on his student account.
